

NOTICE OF VOTE

TO: MEMBERS OF PEERLESS TROUT FIRST NATION

TAKE NOTICE that a Ratification Vote will be held in accordance with the Peerless Trout First Nation Community Ratification Process in order to determine if Eligible Voters approve the *Peerless Trout First Nation Land Code* and the Individual Agreement.

The following question will be asked of the Eligible Voters of Peerless Trout First Nation by ballot:

"Do you approve:

- **The *Peerless Trout First Nation Land Code*, dated November 23, 2023; and**
- **The Individual Agreement with His Majesty the King in Right of Canada?"**

The *Land Code* and Individual Agreement will be approved if a majority of the participating Eligible Voters vote to approve them.

All members of Peerless Trout First Nation who have attained the age of 18 as of the date of the Official Voting Day are eligible to vote.

Official Voting Day for the Ratification Vote will take place on Friday the 22nd day of March, 2024, from 8:30 a.m. until 8 p.m. at:
